**Medical Services:**

**CAMO provides 150,000-200,000 annual medical services to Honduras' most vulnerable populations, addressing critical healthcare gaps through partnerships between U.S. and Honduran professionals. CAMO integrates life-saving education, supplies, and equipment into its programs and healthcare facilities, ensuring dignified, comprehensive care. Services include women's health, disability support, surgical care, medical treatment, and essential health programs for those with little to no access to care.**

**Training and education:**

**As Honduras' national training center for the American Heart Association, CAMO trains thousands of healthcare professionals annually, improving the quality of care for underserved communities. CAMO ensures that every new service, facility improvement, and equipment installation includes hands-on training. Additionally, CAMO supports 17 of the most vulnerable elementary schools, providing textbooks, literacy programs, and teacher mentorship, benefiting over 2,000 at-risk children each year.**

**Community Development:**

**Since 2004, CAMO has partnered with local leaders in Santa Rosa de Copán to improve the lives of the most at-risk populations. Projects include a community gym, cultural center, trade school, public daycare, and a domestic violence shelter, offering protection and intervention for women and children in crisis. A CAMO-built public health center now serves as a national model for healthcare in Honduras. These initiatives contribute to crime reduction, with Honduras' homicide rate dropping from 66 per 100,000 in 2014 to 31.1 in 2024 (USAID/Statista).**

CAMO's first decade focused on building essential infrastructure and developing a counterpart model in 13 medical programs. U.S. and Honduran specialists were paired to provide training and fill critical healthcare gaps in ophthalmology, dentistry, biomedical services, audiometry, and prosthetics.

With a growing influx of donated supplies and equipment, storage space became a priority. Initially housed in an abandoned warehouse and barn, CAMO soon shipped six 53-foot freight containers annually to Honduras.

At the Hospital Regional de Occidente, conditions were dire-buzzards roamed the courtyard, water was trucked in from a river, and the kitchen was blackened with soot from open fires. CAMO addressed urgent needs by building a modern kitchen and laundry facility, dramatically improving conditions for 210 patients daily.

By 1998, CAMO had grown beyond its founder's home and nursing wages. That year, Hurricane Mitch struck, and at the request of the U.S. Ambassador, CAMO led the Crisis Corps relief effort, providing aid in three cities, restoring water systems, and constructing temporary homes over 16 months.

As donations and demand grew, CAMO USA needed a permanent facility. With land, materials, and labor donated, the CAMO USA headquarters was built.

Simultaneously, CAMO Honduras established its corporate headquarters on donated land in front of the regional hospital.

By the end of the first decade, CAMO had grown to 13 programs, serving

Second Decade (2003-2013)

With facilities in both the U.S. and Honduras completed, CAMO's programs expanded, and the counterpart model thrived. Warehouses maintained a steady flow of medical supplies and equipment, ensuring continued support for critical healthcare services.

Responding to community concerns about children and gang activity, CAMO launched several initiatives:

\*Public Daycare: Provided medicine, food, a full-time teacher, and facility improvements-support that continues today.

\*Community Center/Gym: At the mayor's request, CAMO transformed an abandoned, roofless building into a fully functional center now serving 400 children daily.

\*Trade School: Revitalized an abandoned vocational school, reforming its board and expanding programs. Within four years, it graduated 900 students annually across 16 trades.

\*Safe House for Domestic Violence Victims: Completed a five-year project to establish a secure facility that continues to provide refuge and support for women and children in crisis.

To promote financial sustainability, CAMO established the Social Investment Association in Honduras, generating revenue to cover 5% of operational costs annually.

Infrastructure improvements at the hospital continued, including a new electrical system, generator, phone system, medical compressed air, pediatric unit, emergency room, trauma room, endoscopy suite, and x-ray department.

By the end of the second decade, CAMO had expanded to 16 programs, serving 107,000 people annually, increased its shipping to eight containers per year, and grown its staff from 13 to 37 employees.

Third Decade (2013-2023)

CAMO's third decade focused on expanding healthcare access, improving infrastructure, and ensuring long-term sustainability.

After 20 years of requests, CAMO rebuilt the largest public health clinic in western Honduras, which had been collapsing due to failed electrical, water, and sewage systems. Following two years of construction, the renovated 37-room facility now provides over 800 services per day, making it the second-largest clinic in Honduras.

Beyond infrastructure, CAMO advanced healthcare education. It became the national registry for Honduras under the American Heart Association, and the first nursing procedure manual, originally written by founder Kathy Tschiegg in 1981, was revised and implemented in universities and hospitals across western Honduras.

Additional community initiatives included:

\*Orphanage Rehabilitation: Rebuilt the flood-damaged kitchen and laundry and added a computer lab.

\*Trade School Expansion: Increased space and course offerings to create more job opportunities for Honduran youth.

\*Sustainability Growth: CAMO's Social Investment Association generated enough revenue to cover all payroll expenses during COVID, allowing CAMO to remain fully operational.

During COVID, CAMO was one of the only fully functional nonprofits, managing \$2.4 million in World Bank funds for testing and treatment.

Simultaneously, when hurricanes ETA and IOTA devastated Honduras within two weeks, CAMO led the relief effort, building 443 homes for displaced families.

At the close of the third decade:

\*Medical Outreach Expanded: Two Honduran-led medical teams now provide specialty care in rural communities weekly.

\*Counterpart Model Strengthened: The first ophthalmology counterpart now operates the largest eye center in Honduras and was selected as a training center for ophthalmology residency programs.

\*Hospital Upgraded: Due to CAMO's ongoing infrastructure investments, the regional hospital was elevated to a National Hospital.

\*Higher Education Advancement: CAMO's advocacy led to the creation of Honduras' first four-year degree programs in Biomedical Engineering and Respiratory Therapy.

\*Public Hospital Equipment Management: CAMO was recognized by the Minister of Health as the national model for biomedical and hospital equipment management, leading to the construction of a new biomedical/maintenance department with standardized protocols and education.

By the end of the third decade, CAMO had grown from 16 to 25 programs, directly serving over 200,000 people annually, with countless indirect beneficiaries. The organization continued to ship eight containers per year and expanded its team from 37 to 64 employees.
